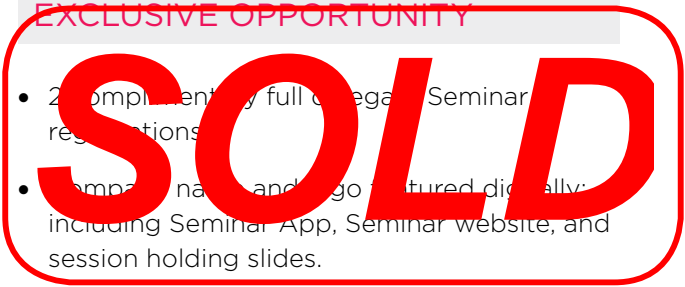

Acceptance and Allocation:

Application and Payment:

Cancellation Policy:
